## 2.2 Format of competitions

The FIG requirements for Juniors and for Seniors will be applied for all phases of competitions.

Event ID, Junior: 14373

Event ID, Senior: 14372

### Competition CI Juniors

5 gymnasts in the team, 4 compete on each apparatus, 3 best scores count.

Qualification for competitions CII and CIII.

Final result for team ranking.

### Competition CI Seniors

5 gymnasts in the team, 3 compete on each apparatus, 3 best scores count.

Qualification for competitions CIV and CIII.

### Competition CII Juniors

The highest 24 ranked gymnasts from competition CI (with a maximum of 2 per NF) are qualified for this competition.

Four (4) reserve gymnasts are designated, taking into account the ranking in competition CI.

### Competition CIV Seniors

The 8 best teams from competition CI are qualified for the team final.

5 gymnasts in the team, 3 compete on each apparatus, 3 best scores count.

### Competition CIII Juniors and CIII Seniors

The 8 highest ranked gymnasts on each apparatus from competition CI, with a maximum of 2 gymnasts per NF, per apparatus.

Three (3) reserve gymnasts are designated on each apparatus.

According to the FIG/TR.

## 2.2.2 The qualifying competition CI Juniors and CI Seniors





- According to the FIG/TR, in case of a tie in points at any place in the competition CI, for qualification for competition CII, CIV or CIII, the tie breaking rules will apply.
- In competition CI Juniors, result for team ranking, in case of a tie in points at any place, the tie will not be broken.
- Starting orders for competitions will be according to the drawing of lots carried out in Bern (SUI) on 6 May 2016, by the UEG/WTC and the LOC.
- For competition CI Juniors and CI Seniors, the draw for mixed groups will be made amongst the national federations with individual gymnast(s). The starting order of the teams and mixed groups will be made by drawing of lots according UEG/TR:
  - The 8 best teams from European Championships 2014 are to be drawn in the last subdivision.*
  - Juniors RUS, GBR, ROU, GER, ITA, BEL, FRA, SUI
  - Seniors ROU, GBR, RUS, GER, ITA, ESP, BEL, SUI
- If a national federation has made a nominative inscription with a team and will present only individuals by the time of the competition or if the number of individuals is less than the number of the gymnasts from the nominative inscription by the time of the competition, the UEG/WTC is entitled to make adjustments of the starting order for the competition, according to the actual number of gymnasts present at the competition.
- **Team:** the competing order for gymnasts in a team is decided by the national federation.
- **Mixed group:** NF with more than one gymnast must submit the order for their gymnasts on each apparatus.



- The competing order of the teams/mixed groups will not alternate during the competition. The gymnasts of the first team/mixed group will warm-up and compete; then the gymnasts of the second team/group will warm-up and compete. The team/mixed group will compete in the same order in the subsequent apparatus.
- If one gymnast is not competing on all apparatus, she has the right to leave the competition area and warm-up in the warm-up hall. The gymnasts may return upon their own wish.

### 2.2.3 The team final competition CIV Seniors

- According to the FIG/TR, in case of a tie in points at any place in the competition CIV, the tie will not be broken.
- The competing order of the teams will not alternate during the competition. The gymnasts of the first team will warm-up and compete; then the gymnasts of the second team will warm-up and compete. The team will compete in the same order in the subsequent apparatus.
- The numbers correspond with the ranking of the teams after competition CI.
- If one gymnast is not competing on all apparatus, she has the right to leave the competition area and warm-up in the warm-up hall. The gymnasts may return upon their own wish.

## 2.2.5 The apparatus finals competition CIII Juniors and CIII Seniors

- According to the FIG/TR, in case of a tie in points at any place in the competition CIII, the tie will not be broken.
- If more than 8 gymnasts are qualified in one apparatus final, a draw will take place, to determine the starting order.
- The draw was made in Bern on 2 April 2016, by the UEG Vice-President and the UEG/WTC.

## 2.3 The touch warm-up during the competition

Warm-up times according to the FIG rules.

- Competition CI, CII and CIII juniors on the podium.
- Competition CI and CIV seniors on the podium.
- Competition CIII seniors in the warm-up hall **only**. (Prior to the start of competition CIII, a timed/controlled warm-up period of one hour accorded to the gymnasts will take place on the podium up to 30 minutes before the start of the competition).

## 2.4 Access to the competition area

The competition area is accessible to members of various juries, competing gymnasts and their accredited coaches, to local group leaders, to the auxiliary personnel of the Jury, to the President of the UEG Medical Commission, to the official doctor, to the team doctors, medical staff and to persons concerned with the apparatus. A team medical person is permitted to accompany the gymnasts and coaches during all competitions.

Interpreters may not enter the competition area without the permission of Mrs. Yvette Brasier, the President of the UEG/WTC. The competition area is strictly forbidden to all other persons.

According to the FIG/TR, two coaches (or assisting persons) and medical person will be allowed for each team for the team competition, and only one coach for each gymnast for the individual competitions.

### **According to the UEG/TR Art. 13.1 Use of electronic communication devices**

*The use of any kind of electronic devices (video, mobile phones, etc.) is strictly forbidden in the competition area.*

*Please note that, according to the decision of the Executive Committee of the European Union of Gymnastics from February 2016, the use of mobile phones or any other electronic communication device by gymnasts, coaches, judges or medical staff of the delegations on the field of play is forbidden during the entire duration of the competitions of official UEG competitions.*

*If this rule is violated, the concerned persons will receive a written warning.*

*If this behaviour is repeated after the written warning is issued, the concerned person will be excluded for the rest of the competition.*

*The Superior Jury is responsible to decide these disciplinary measures. Appeals against these decisions have to be submitted to the Jury of Appeal whose decision is final.*

## 2.5 The award ceremonies

The award ceremonies will take place according to the schedule and will be organized as follows:

- Competition CI Juniors (team ranking): Gold, Silver and Bronze medalists on the podium
- Competition CII Juniors: 8 best ranked gymnasts on the podium
- Competition CIV Seniors: Gold, Silver and Bronze medalists on the podium
- Competition CIII Juniors: Gold, Silver and Bronze medalists on the podium
- Competition CIII Seniors: Gold, Silver and Bronze medalists on the podium

According to the FIG/TR, the gymnasts are requested to wear competition attire during the awarding ceremonies.

According to the UEG Directives for the organization of Ceremonies, the participation of the medal winners in the award ceremonies is compulsory. Gymnasts or teams that are absent for unjustified reasons will be disqualified.

## 2.6 The apparatus supplier

The apparatus supplier of this European Championships is SPIETH GYMNASTICS.

- Both training halls will be provided with: 1\* vault – 2\* uneven bars – 2\* beams – 1\* floor
- The warm-up hall will be provided with: 1\* vault – 1\* uneven bars – 1\* beam – 1\* floor

## **2.7 The scoring and distribution of results**

Directly after competition CI, the scoring office will produce:

- lists of the final ranking of competition CI
- list of the ranking of all teams
- list of the qualified gymnasts (and reserves) for competition CII Juniors
- list of the qualified teams for competition CIV Seniors
- list of the ranking of all the participants on each apparatus
- list of the qualified gymnasts (and reserves) per apparatus for competition CIII

These lists, as well as the results after each event, will be given to the Heads of Delegation and to the UEG as soon as possible. A print-out of the final results of each competition will be provided in the mailboxes at the information desk. All intermediate and final results will be sent by e-mail to the Head of Delegation.

At the end of all competitions all delegations will be provided with a complete set of results including the judges' individual scores for all competitions.

## **2.8 The orientation meeting**

The presence of the participating NF to the orientation meeting is mandatory. A maximum of three members per delegation is recommended, including the Head of Delegation. Unjustified failure to attend will result in a sanction against the federation of Euro 1'000.

## **2.9 The competitions numbers (Bib)**

Two (2) sets of starting numbers will be provided to the Head of Delegation by the LOC during the orientation meeting. The numbers have to be firmly attached to the competition attire throughout the whole competition.

## **2.10 The written exercises**

It would be appreciated if NF submit their gymnasts' exercises in symbols notation before the podium training at the very latest to Mrs. Anca Mihailescu-Grigoras, Responsible for Judges UEG/WTC.

## **2.11 The new elements**

## **2.12 The anti-doping control**

Any doping is prohibited. An anti-doping control can be requested at any time. Anti-doping controls will be made as per Anti-Doping Control Regulations of FIG and VADA.

## **2.13 The medical orientation meeting**

The presence of at least one member of the medical staff of the participating NF to the medical orientation meeting is strongly recommended. NF without medical staff should be represented by another member of the delegation.

The Jury of Appeal is composed of two members of the UEG Executive Committee (one of them acting as President) and a member of the LOC who was not involved in the decision of the Superior Jury and the judging process on the concerned apparatus.

### 3.3 The Apparatus Jury





All registered judges must hold the FIG judges brevet (13<sup>th</sup> cycle). The log book must be presented at the judges' course. To be allowed to judge, the judges must have taken part in the judges' course, in the drawing of lots and in the briefings preceding the competition. In case there is an insufficient number of judges from the participating present NF, the UEG/WTC decides the process for designating the necessary number of judges.

If a NF has a judge selected in the D2-jury or in the R-jury, its other registered judge can be drawn as E-judge or assistant in a Junior and/or Senior competition if needed (cannot be on the same apparatus). If there are not enough judges in a Junior and/or Senior competition, it's possible to use the same judge in both competitions.

#### 3.3.1 The D-jury

- D1-judges (Difficulty Judges) were drawn by the UEG/WTC in Bratislava on 19 November 2015 from amongst those with FIG Brevet category I.

### 3.3.2 The E- and R-jury

- E-judges (Execution Judges) will be decided by drawing of lots on site.
- R-judges (Reference Judges) were drawn by the UEG/WTC after the definitive registration (3 March 2016) in Bern on 1 April 2016.
- R-judges remain at the same apparatus throughout the entire Juniors' and in Seniors' competition if possible.
- For team final competition CIV Seniors, only judges from federations without qualified team will be allowed to judge in the E- or R-jury if there are enough neutral judges.
- For apparatus finals competition CIII Juniors and Seniors, only judges from federations without qualified gymnasts (including the first reserve) will be allowed to judge in the E- or R-jury at the concerned apparatus.
- All entered judges must be available until the drawing of lots for the last competition of the respective European Championships. Exceptions have to be managed by Mrs. Yvette Brasier, the President of the UEG/WTC.

As a reminder and according to the UEG/TR the function of judge cannot be combined with any other function.

### **3.4 Judges' instruction and draw of lots**

According to the UEG/TR, the presence of the judges to the judges' instruction is mandatory. The judges' instruction will be held in English. The judges' oath will be carried out at the end of the judges' instruction, by one of the host federation's judge.

### **3.5 Inquiries of the score**

Inquiries for the difficulty scores are allowed, provided that they are made verbally immediately after the publication of the score or at the very latest before the score of the following gymnast is shown. For the last gymnast or group of a rotation, this limit is one minute after the score is shown on the score board. The person designated to receive the verbal inquiry has to note the time of receiving it and starts the procedure.

Only the accredited coaches in the competition area are entitled to submit an inquiry. The form Inquiry – (2.08) List of authorised coaches signed by the Head of delegation has to be handed over at the Orientation meeting on Monday, May 30<sup>th</sup>, at 09h00.

Late verbal inquiries will be rejected. A federation is not allowed to complain against the scores of a gymnast from another federation. Inquiries for all other scores (Execution, Artistic) are not allowed.

The inquiry must be confirmed as soon as possible in writing, but within 4 minutes at the latest after the verbal inquiry and requires an agreement of payment of Euro 300.- for the first complaint; Euro 500.- for the second complaint and Euro 1'000.- for the third and any further complaints during the event. Should the inquiry not be confirmed in writing within 4 minutes, the procedure becomes obsolete.

If the inquiry is refused, the amount will be invoiced later on and must be paid within 3 months. If the inquiry is accepted, no amount will be requested. Every inquiry must be examined by the Superior Jury and a final decision (which may not be appealed) must be taken at the very latest:

- at the end of the rotation/group for the qualifying competitions, the all-around competitions and the team competition (final)
- before the score of the following gymnast is shown for the apparatus finals.

## 4 THE ORGANIZATION OF THE EVENT

---

### 4.1 Training information

Two sessions of training will be provided to the participating federations. The minimum time between the two daily training sessions for a group must be 4 hours.

A detailed program of the training will be provided to the participating NF after the draw. The delegations are obliged to respect the training schedules.

The training hall Bernexpo (Hall 2.2) is available from Monday 30 May 2016. Additional training on Sunday 29 May 2016 at 13:30-19:30 on request by e-mail to the LOC before 11 May 2016.

After competition C1 the training request form for *training upon request* according the training schedule must be submitted to the information desk 24 hours before the concerned training.

D-jury (D1- and D2-judges) may assist to all sessions of training.

R- and E-judges may attend training sessions only during the training session of their own team.

### 4.2 The official podium training

A detailed program of the official podium training will be provided to the participating NF.

The presence of all judges at the official podium training is mandatory.

### 4.3 The delegation

Gymnasts who do not have correct age and a valid FIG license (or the validity of license is expired) are not allowed to compete. According to the UEG/TR, the maximum composition of the delegation for the European Team Championships is as follows:

### 4.4 The accreditation

The accreditation office will be located at the competition venue. Upon accreditation the Head of Delegation or his/her representative will have to provide to the LOC the following:

- The passport of the gymnasts and judges
- The licences of the gymnasts
- For medical persons, the proof of their professional competences (copy of diploma or professional card)
- Proof of insurance coverage of the delegation
- Proof of the fulfilment of all financial obligations to the LOC (accommodation, meals, airport transfer (if applicable))
- The correctness of national flag and anthem of the country, to be confirmed with the form "Confirmation of the national flag and anthem"
- Floor music and "music release form", if not sent to LOC previously
  - o Hand in one set of back-up audio CDs of their gymnasts' floor exercise music, including for each audio CD the name of the NF and the 3 letters in capital used by FIG for the country code, the name of the gymnast, the name of the composer and of the title of the music and the exact length



of the music. These back-up audio CD's must be brought for safety reasons, and will be returned at the closing banquet.

- An additional set of CDs has to be brought for the training sessions.
- Hand in the request for raising the bars of 10 cm
- Departure confirmation
